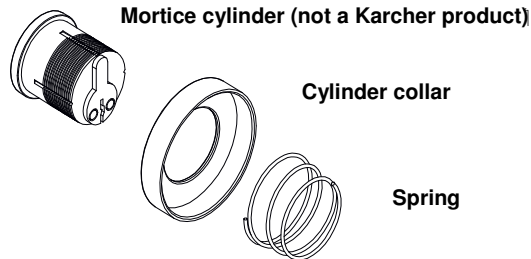


Assembly for US-Cylinder Collar (UEZ1332 CC)



1. The mortise cylinder is not a Karcher product. The Karcher cylinder collar has a height of 3/8" (10mm). Depending on your door thickness the mortise cylinder height has to be chosen.
- 2.)Put the mortise cylinder through the hole in the cylinder collar and the spring.
- 3.) Insert the mortise cylinder into the mortise lock by turning it in.
- 4.) Due to the spring the cylinder collar will be pushed to edge of the mortise cylinder.
